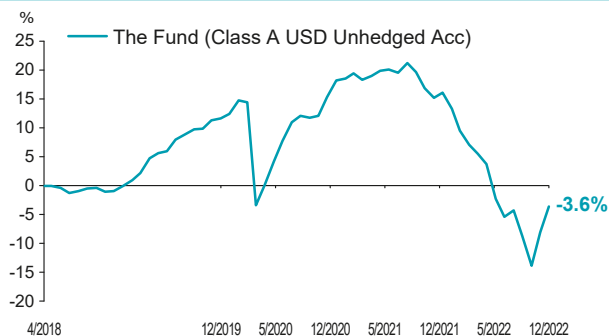

- The Fund primarily invests in the Asia Pacific markets and therefore is subject to emerging market and concentration risks. As the risk of default increases disproportionately as a bond's rating decreases, the simple weighted average of credit ratings is not a statistical measurement of the portfolio's default risk. 13. Benchmark's top Mutual Funds are selected based purely on quantitative data in its BlueOrion fund database. The subset awards strategies who have demonstrated medium-to-long-term tangible outcomes without subjecting the investors to unnecessary risks. 14. The assessment of each award category is based on 3 weighted criteria, and one weighted criterion based on feedback from private banking fund selectors.
