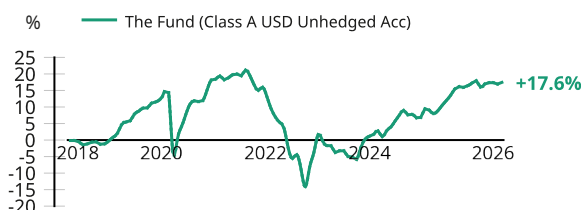

The top-ranked house has garnered the most votes for Astute Investors and so on. All votes are also subject to a weighting methodology. The top-ranked houses by institution type are announced in The Asset magazine and on TheAsset.com. **13.** Benchmark's top Mutual Funds are selected based purely on quantitative data in its BlueOnion fund database. The subset awards strategies who have demonstrated medium-to-long-term tangible outcomes without subjecting the investors to unnecessary risks. **14.** The assessment of each award category is based on 3 weighted criteria, and one weighted criterion based on feedback from private banking fund selectors.
