Investment objective

The Fund aims to provide capital appreciation by primarily investing in Greater China debt securities, including but not limited to high yield, convertible and mainland Chinese offshore bonds.

Commentary

Portfolio review:

Global markets remained range-bound in May, with the 10-year US treasury yield benchmark ending slightly lower for the month. In Asian credit markets, high yield outperformed the investment grade universe due to higher income. We continued to fine-tune our China property positions and deployed some capital into select industrial names. We expect to maintain the current allocations in the foreseeable future.

Outlook:

There have been increasing talks about potential inflation and Fed tapering after a series of strong US data. The Fed has reiterated its intention to keep interest rates low to ensure that the US economy can sustain the Fed's 2% inflation target. However, we believe long-term yields will rise gradually as the recovery continues, resulting in a steeper yield curve. It is therefore important to pay attention to the pace of the US recovery, its inflation rate, and employment numbers. The efficacy of the vaccine roll-out and the global pandemic situation will also have great implication for the pace and path of the current recovery.
