**Value Partners Young Fellowship Program
Admitted University Talents in Hong Kong for Internships**

Ms. Clara KWAN Chi-hang, managing director of Human Resources at Value Partners, said: “We have partnered with HKUST to run the Value Partners Young Fellowship Program since 2017, and feedbacks from both the students and our hiring managers are positive. We noted the talent retention rate is satisfactory and this Program has helped achieving our primary goal to build young talents for Value Partners and the asset management industry.”

Value Partners always treasures talents. Besides the fellowship program with HKUST, our group joined The University of Hong Kong Asset Management Corporate Series for their Year 2 and Year 3 students and sponsored one sharing session in January this year. Our group also participates in the Pilot Programme to Enhance Talent Training for the Asset and Wealth Management Sector (“WAM Pilot Programme”) funded by the Hong Kong Special Administrative Region Government and organized by the Hong Kong Securities and Investment Institute, and has been providing internships to non-final year undergraduate students in organizations of the WAM sector for three years.
