## **Value Partners Appoints CAI Shaojun as Managing Director and Head of Fixed Income**

As part of a planned succession process, Mr CAI and Mr IP are working closely through a structured handover covering portfolio oversight, investment process, risk management and client engagement. The existing fixed income team and investment governance framework will continue to support the function, ensuring continuity in Value Partners' fixed income investment philosophy, risk discipline and client service during the transition and beyond.
